# **Treasurer Report**

# **Budget and Finance Committee**

As we are ready to close the books for FY 2023 we would like to report that our Legion is on solid ground.

It is projected that we end the year with a surplus. <u>However, it is difficult to report as we have a number of expenses, including this convention to be paid and will be reported at the next NEC meeting.</u>

Our Finance Committee has reviewed our FY '23 budget and has made recommendations for FY '24.

# Budget 2024

Our budget for FY '24 of \$572,726.00, which was recently approved at a meeting of the Finance Committee via zoom. Our new budget is one that will maintain continuity for all programs, services as well as our operational cost to fund our Department. It reflects a decrease of nearly \$90,000, which takes into consideration the deductions in spending during FY' 23. Although there were shortfalls in income due to low membership numbers, our Department staff showed very modest spending patterns throughout the year, saving unexpected revenue.

As of this report and as we come to the close of our fiscal year, we find all committees have completed their mission as we keep with the fine tradition of the American Legion, as we have known, in years past.

# **Investments**

Total investments, as of <u>6.09.2023</u> are at <mark>\$4,008,009.55,</mark> up from previously reported at the last June DEC meeting in 2022. We have had a gain of <del>\$230,283.36.</del> Or roughly 5.8% increase over the last 12 months of investments.

These numbers are actually up a bit from my report at the Department Executive Meeting on 6/8/2023 as I thought I would give one final check as to our investments for my Convention report.

Goes to show you, the difference a day makes! (\$12,502.72)

These funds are closely monitored by our Legion Finance and Investment Committees, with meetings that take a hard look at methods to maintain a sound portfolio.

The latest numbers on the Consolidated Post Report were just released, by Department.

District 1 – Berkshire County, has 10 posts, 4 have not submitted a CPR – 63.6 completion rate

District 2 – Franklin/Hampshire County has 15 posts, 10 have not submitted a CPR – 33.3% completion rate

District 3 – Hampden County Has 22 posts, 9 have not submitted a CPR – 59.1% completion rate

District 4 – Worcester County has 54 posts, 36 have not submitted a CPR – 33.3% completion rate

District 5 – Middlesex County has 46 posts, 26 have not submitted a CPR – 39.1% completion rate

District 6 – Norfolk County has 28 posts, 14 have not submitted a CPR – 50% completion rate

District 7 – Suffolk County has 21 posts, 7 have not submitted a CPR – 66.7% completion rate

District 8 – Essex County has 33 posts, 16 have not submitted a CPR – 48.5% completion rate

District 9 – Bristol County has 21 posts, 9 have not submitted a CPR – 60.0% completion rate

District 10- Ply/Barn/Dukes/Nan County has 32 posts, 17 have not submitted a CPR – 46.9% completion rate

So out of 285 posts 148 didn't submit a CPR – 52% completion rate

National has us at 36.6%, which is 20<sup>th</sup> place of all Departments of the American Legion and in 5<sup>th</sup> place in the Northeast Region.

Of all the posts 12,112 posts only 3,567 have submitted a CPR to National for a completion rate of 29.5%.

# 5 Social members are not recognized by The American Legion

# A Federal statue states you only have active members:

"An individual is eligible for membership in the corporation only if the individual...has served in the Armed Forces..." Further definitions within the chapter narrow down membership eligibility from there to specify periods of war relevant to the statute, but the key word in there is "only" which would preclude any form of membership offered to anyone outside the criteria enumerated.

Further, our National Constitution states in Article IV, Section 2 that:

# Section 2. There shall be no form or class of membership except an active membership, and dues shall be paid annually, for multiple years, or for life.

#### **B** Commonwealth states

Veterans clubs when a member brings in a guest the member is the one who buys their drinks, and when the member leaves the guest needs to leave with them.

In 1987 I went into a post in NC the bartender ask for my membership card, someone from across the hall yelled that's the National Commander. I still showed my membership as the bartender is responsible on serving the drinks to Veterans. Only members can buy a drink and the nonmember must leave when the (Veteran) post member leaves. Nonmembers should be signing in the book with who they came in with. If the ABC comes to your post and you are selling to nonmembers they will take your lease and shut your post bar down

I would like to send this to Dick Pastor so he can look up the ABC rules for the Commonwealth of MA and the National letter so the Department can mail to each post.
